- Will have to undergo Police Basic Training at recognized Police Training Centre as ordered by the authority concerned and ensure proper attendance and discipline in the training institute.
- 2. Successful completion of basic training.
- 3. True and sufficient disclosure of the information while filling up each and every column of attestation form.
- 4. A Comprehensive Character and Antecedent verification of the candidate to the fullest satisfaction of the department. If any adverse remarks received about the character and antecedents, the service will be terminated forthwith.
- The appointment will be purely temporary and may be terminated at any time without assigning any reason(s) thereof.
- 6. Will be on probation for a period of two years.
- 7. Will be required to serve at least for 3 years from the date of joining, unless you are discharged or dismissed or certified by a Civil Surgeon to be unfit for such service. If the individual resigns before the expiry of the said three years, he has to refund the cost of training, i.e. pay drawn during the period of training plus the expenses of TA to join the training school
- 8. Will be required to serve anywhere in Arunachal Pradesh where posted or detailed. Will have to serve in Arunachal Pradesh as well as outside of the state if deployed.
- 9. The inter-se seniority in the rank of Constable (Driver) Civil Police in respective unit will be determined on the basis of marks obtained on conclusion of the basic training.



- No TA/DA will be admissible to join duty/Training.
- 11. The CCS Pension Rule 1972/ GPF shall not be applicable

The other terms and conditions of service which are not specified herein shall be in accordance as per the relevant rules in force from time to time.

The candidates willing to accept the terms and conditions mentioned above, should report to Principal PTC Banderdewa on 13/01/2025 repeat 13/01/2025 for further basic training along with 1. Personal belongings, 2. Light bedding, 3. Approx. Rs.5,000/- as mess advance, 4. Steel Plate / Mug / Spoon and 5. Admit card issued during recruitment.
