The appointment to the post of **Constable (Driver)** against the existing vacancies of **Civil Police, AAP Bn & IRBn** in APP shall be subject to the following conditions: -

1. True and sufficient disclosure of the information while filling up each and every column of attestation form.

2. A comprehensive Character and Antecedent verification of the candidate to the fullest satisfaction of the department. If any adverse remarks received about the character and antecedents, the service will be terminated forthwith.
3. Will have to undergo Police Basic Training at the designated training centre. The appointment will be effective from the date of joining at the Training Centre.
4. Timely report to the respective training centre, failing which shall be liable to rejection of the candidature.
5. Will have to undergo Police Basic Training and ensure proper attendance and discipline in the Training Institute.
6. Successful completion of basic training.
7. The appointment is purely temporary and may be terminated at any time without assigning any reason(s) thereof.
8. Will be on probation for a period of two years.
9. Will be required to serve at least for 3 years from the date of joining, unless discharged or dismissed or certified by a Civil Surgeon to be unfit for such service. If the individual resigns before the expiry of the said three years, he/she has to refund the cost of training, i.e. pay drawn during the period of training plus the expenses of TA to join the training institute. However, in the case of an individual who technically resigns from the Police Department before expiry of the said three years for joining same/higher grade post within the establishment of the Arunachal Pradesh Police Headquarters (Civil Police/AAPBn/IRBN) or Fire & Emergency Service, he/she shall be exempted from the refund of cost of training i.e. pay drawn during the period of training plus the expenses of TA to join the training school. Continuity of service in the Arunachal Pradesh Police will be requisite condition.
10. He is required to serve anywhere in Arunachal Pradesh or outside the state where posted or detailed.
11. The inter-se seniority in the rank of Constable (Driver) Civil Police, AAPBn & IRBN in the respective cadre will be determined on the basis of marks obtained on completion of basic training.
12. No TA/DA will be admissible to join at PTC Banderdewa for basic training.

The other terms and conditions of service which are not specified herein shall be in accordance as per the relevant rules in force from time to time.

The candidates willing to accept the terms and conditions mentioned above, should report to Principal PTC Banderdewa on 18/05/2025 repeat 18/05/2025 (Sunday) at 0900Hrs for further basic training. The joining Notice/instructions can be viewed in [www.arunpol.nic.in](http://www.arunpol.nic.in).


