TERMS AND CONDITIONS

- 1. The Limited Tender must be enclosed in suitable cover which must be sealed and superscripted in red ink "Quotations for WT equipment for training sector" Local tenderers may drop their tenders to tender box in the Office of the Supdt of Police (Telecom), Chimpu during office hours. Tender should be addressed to the undersigned by designation and not by name.
- 2. The Limited Tenders will be received from 28/08/2023 0930 hrs to 15/09/2023 1100 hrs and opened publicly in the office chamber of IGP(Admn), PHQ Itanagar at 1130 Hours of the same day. If the office remains closed on the scheduled day for any valid reason, the tender will be opened on the next working day at the same time and at the same venue. Tenders received beyond stipulated time shall not be entertained. Pre-Bid meeting will be held on 04/09/2023 at SP(Telecom) Office Chimpu. The tenderers or their authorized (with authorization proof) representative have the liberty to be present during the Pre-Bid meeting and opening of tenders.
- 3. All the tenders must be accompanied with earnest money @ 2(two) percentage of the estimated cost of the items mentioned in the list of items enclosed as annexure. The earnest money deposit will be accepted in the form of Demand Draft/TDR/FDR or Bank Guarantee from any of the commercial banks in an acceptable form, safeguarding the purchaser's interest in all respects. The earnest money deposit is normally be to remain valid for a period of forty-five days beyond the final bid validity period. Tenders without earnest money will be summarily rejected. The tenderers are required to pledge earnest money deposit in the name of Supdt of Police (Telecom), Chimpu. Bid security should be refunded to the successful bidder on receipt of performance security & Execution of deed of Agreement.
- 4. Successful tenderers will be required to furnish 3% of the total value of the article to be supplied as Performance Security within 15 days from the date of issue of letter of acceptance of tender. The successful tenderers will have to enter into a "Deed of Agreement" stipulating the terms and conditions of the contract. Security deposit will be subject to forfeiture in case of non fulfilment of any or all the terms and conditions of the contract. Earnest money of the successful tenderers will be forfeited by the Government in case of failure to furnish security money and execution of Deed of Agreement. The performance security should remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the supplier including warranty obligation.
- 5. Successful tenderers have to supply the items within 90(ninety) days from the date of issue of Supply order failing which 3 % of Performance Security deposit will be forfeited and supply order will be cancelled OR sum equivalent to 0.5 % of delivery price of the delayed items for each week delayed or part thereof beyond the original contract delivery period will be recovered to a maximum of 10 % as a liquidated damages.
- 6. Any breakage or loss of any items en-route or in transit will be at the supplier's risk.
- 7. If any item is found damaged or otherwise unacceptable at the time of delivery/ inspection, the suppliers will be required to remove the same from SP (Telecom) Office, Chimpu, Itanagar, and Arunachal Pradesh at their own cost within 15 days. The supplier should arrange replacement of such damage / rejected item / item(s) in their own cost within 3(three) weeks from the date of removal of item / item(s) from the office of the supdt. of Police (Telecom) without further delay to avoid cancellation of supply order and forfeit the security money deposited against such rejected item / item(s).

- Rate should be quoted F.O.R. SP (Telecom), Chimpu, Itanagar Arunachal Pradesh. Rate quoted 8. other than F.O.R SP (Telecom) Office, Chimpu, Itanagar shall not be accepted, no packing or forwarding charges will be allowed. The rate of GST (as applicable) may be charged/quoted by the tenderers and the amount be clearly mentioned for all items. The rate should be quoted in Indian currency both in figure and words clearly. Tenders must be eligible and clear in all respect else the tenders shall be liable to be rejected.
- Payment will be made to the supplier directly on completion of supplies/installation and on receipt 9. of stores after acceptance by the govt. nominated board.
- The Director General of Police, Itanagar, and Arunachal Pradesh reserves the right to reject the 10. lowest or all or any of the tenders without assigning any reason thereof.
- The tenders must be accompanied with attested copies of GST registration certificate, valid trading 11. licence without which the tender would be out rightly rejected.
- The tenders must also accompany valid license for trading of these required items and experiences 12. in supply.
- The firm/tenderer shall quote their rate against each item both in figure and in words. 13.
- The tenderers should sign in every page of the tender bearing rates. Similarly, the tenderers should 14. also authenticate all correction of rate/ items in the tender, if any.
- Name of equipments /items with specifications at Annexure A. 15.
- Ouantities mentioned in the enclosure are all approximation and subject to variation as per actual 16. availability of fund.
- Tender will remain valid up to 31.03.2024 17.
- The Director General of Police of Arunachal Pradesh, Itanagar shall have the right to ask the firms 18. to demonstrate their items before the items are accepted.. Firms qualified in initial scrutiny shall provide a practical demonstration of equipment in compliance with the specification of tender for Technical evaluation.
- Name of the item with specifications and approximate requirement are enclosed herewith. The 19. Tenderers shall submit the sample of the items/photographs with specification/ details of make & model of manufacturer etc along with the bid documents.
- All items to be supplied shall be on warranty for a period as mentioned by the manufacturing 20. company. Where the warranty period has not been mentioned, the minimum warranty period shall be for one year (except consumable items).
- If any dispute arises out of this contracting agreement the same shall be brought before the Civil 21. court at Yupia having appropriate jurisdiction over the matter and whose decision shall be final and binding to the parties to this contract.
- The tenderer should present sample of the item tendered before the board on the date of opening of 22. tender i.e. on 15/09/2023 at 1130 hrs.
- The item should not be "Made in china". 23.
