// LIMITED TENDER NOTICE //

1. Director General of Police, Arunachal Pradesh, Itanagar invites sealed "Tender" in plain paper from the manufactures/authorized dealers/agents for supply of firefighting equipments and other items against Rajbhawan Itanagar as details at **Annexure-A**. The tender will be received by the undersigned up to 1100 hours on 23/01/2023, which will be opened on the 24/01/2023 at 1130 hours. The tender value is Rs.3,50,000/- (Rupees three lakh fifty thousand) approx. The tenderers or their representative (s) may remain present at the time of opening of tenders. Tenders received after scheduled date and time will not be entertained:
2. All the tenders must be accompanied with Tender fee of Rs.1,000/- (Rupees one thousand) only in the form of Bank Draft in favour of Superintendent of Police, Fire & Emergency Services, Itanagar payable at SBI, Itanagar along with tender. Tenders without tender fee will be summarily rejected.
3. All the tenders must be accompanied with Earnest Money of Rs.7,000/- (Rupees Seven thousand) only. Tenders without Earnest Money will be summarily rejected. The tenderers are required to pledge National Saving Certificate/ Kishan Vikash Patra / TDR / FDR / Demand Draft etc. of Nationalized Bank / Post Offices in the form of Earnest Money in the name of Head of Office i.e. Superintendent of Police, Fire & Emergency Services, Itanagar from which the work is being allotted to them.
4. All the tenders must be accompanied with attested copy of valid Tax Registration Certificate and Trading License of Fire Fighting and rescue equipments issued by the competent authority. The tenders must be legible and clear in all aspect else the tenders shall be liable to be rejected.
5. Tenders should be quoted in two bid system, Part-I Technical bid and Part-II Price bid and should be kept in separate sealed cover. Price should not be indicated in the Technical bid. Financial bids shall be opened only of these bidders whose sample will qualify before the committee.
6. Rate should be quoted F.O.R Directorate of Fire & Emergency Services, Ganga, Itanagar. Rate should be quoted for per item inclusive of GST.
7. The tenderers have to submit samples of all the items along with tenders.
8. Technical compliance statement of specification should be enclosed along with technical bid clearly indicating the deviation, if any.


9. The stores supplied must be of the same specification/approved tender samples.
10. Any damages or loss of any item enroute or in transit will be at the supplier's/contractor's risk. If any item is found damaged or otherwise unacceptable at the time of delivery/ inspection, the supplier will be required to remove the same from Store of Directorate of F&ES, Itanagar, Arunachal Pradesh at their cost within ten(10) days.
11. Once the sample is approved no change in quality or specification will be entertained.
12. Payment will be made to the contractor directly on completion of supply of correct receipt of stores. Documents, Vouchers/RRs/Bill etc. routed through banks will not be accepted.
13. Consignment should be dispatched by the firm after payment of freight charges at source. Freight TO PAY consignment will not be accepted.
14. Tenders should be addressed to the undersigned by designation and not by name. The sealed envelope containing the tender should be subscribed as "TENDER FOR SUPPLY OF FIRE FIGHTING EQUIPMENTS AND OTHER ITEMS AGAINST RAJBHAVAN, ITANAGAR" and be sent to the undersigned by Registered Post or put in the Tender Box kept at Directorate of F&ES, Itanagar during office hours i.e. from 0930 hours to 1700 hours on any working day.
15. Item should be supplied within the period of time which will be stipulated in the firm supply/work order.
16. The quantity mentioned above is all approximation and subject to variation as per actual availability of fund.
17. Director General of Police, Arunachal Pradesh, Itanagar reserves the right to reject the lowest or all of the renders without assigning any reason(s) thereof.
18. Rates quoted in the tenders and the contract will remain valid up to 31st March' 2023.
19. In case of any legal dispute, legal jurisdiction will be at Itanagar, Arunachal Pradesh.
20. In case of any holidays or unavoidable reason such as bandh call etc. falling on the date of opening of tenders, the tenders will be opened on the next working day.
