

Financial bids will be opened after detailed scrutiny of technical bids of only that Bidder whose technical bid as well as performance of their equipment / products so demonstrated are found acceptable as per Technical Evaluation.

Sample / Products so demonstrated have to be deposited with the department for further comparison with bulk supply which will be returned on request of the company after completion of the supply.

If the supply is found to be inferior, the entire consignment will be rejected at the cost, risk and freight of the supplier.

If the company or its OEM has already supplied the same product to Indian Police Forces in the past, it is exempted from sample submission. However, an undertaking by the company with Proof of Purchase Orders of Past supply by the company or its OEM must be submitted along.

The technically qualified firms will be informed about date & time of opening of financial bids in due course of time.

3. The Tender documents must be provided in two (02) covers:

1. **Cover-1:** It shall contain scanned copies of eligibility information as under.

- a) Valid attested copy of Trading license / Company / Firm Registration Certificate issued by competent authority for the tendered items.
- b) Attested copy of firm GST Registration.
- c) Attested copy of PAN Card.
- d) Original letter of authority in respect of authorized distributors / dealership or Manufacturer Certificate (OEM) etc.
- e) Technical bid along with its original specification leaflets, brochure, catalogue / literature, if any of each tendered item.
- f) Latest Financially soundness certificate / Bank Solvency Certificate of turnover of Rs. 10.00 Crore cumulative turnover in the last four years supported with certified copies of the Charter Accountant. Further, startups recognized by DPIIT are exempted as per GOI guidelines, but must submit the valid start-up certificate along.
- g) Attested copy of last three years Income tax return of the firms. Startups recognized by DPIIT are exempted.
- h) Undertaking letter about non-blacklisting of the firm.
- i) Tender documents duly completed and signed BUT without indication of the rates "Quoted".
- j) Earnest Money (EMD) must be attached in form of TDR/FDR/Demand Draft/NSC/KVP etc. of Nationalized Bank/Post offices duly pledged in favour of Asstt. Inspector General of Police (E), PHQ, Itanagar. However, NSIC / SSI / UAM- MSME certificate, applicable to those who are seeking exemption from EMD.
- k) Bidder should enclose the mandatory certificate/licenses issued to its OEM by the Govt. authorized Labs or Centers about the quality of the equipment quoted. Quality certificate required: NABCB approved ISO: 9001, ISO: 14001, ISO: 45001 for specialized Defence equipment, BIFMA and IGBC Membership along with Greenguard and ISO: 50001. BIFMA Membership Proof of the OEM to be shown as uploaded on official BIFMA website. (Documents must be uploaded with technical Bid).
- l) Experience of the firm. As proof of experience, the bidder should submit the details of similar projects executed by them of minimum Rs. 5.00 Crore (Single or multiple orders) supplied by the bidder or its OEM to any Central Govt. / State Govt. Police Departments during last five years.
- m) The bidder or its OEM must be a manufacturer of all of the said items in the tender. An undertaking to this effect must be given.

2. **Cover-2:** It shall contain documents on "Financial Bid / Price Bid".

- a) Financial bids shall be opened only of those bidders who have been declared technically qualified by the committee.
- b) Price to be quoted in lump sum for all the items / total quantity inclusive of all Taxes.
- c) Unit cost along with break-up of each item to be submitted in a sealed cover along with the Bid document which is mandatory.
- d) Offers with such stipulation like "as applicable" will be treated as vague and are liable to be ignored.
- e) The criteria for eligibility and qualifications are to be met up by the bidders such as minimum level of experience, past performance, facilities and financial position etc.

GENERAL INSTRUCTION:

1. The tenders received after scheduled date & time will not be entertained. The tenderers or their representative may remain present at the time of opening of tenders.
2. Rates must be clearly written in figures as well as in words, Showing GST separately.
3. There should not be any cutting / over writing.
4. The Tenderer / Firms who fail to fulfill the eligibility conditions will be summarily rejected.
5. The firms will have to submit all required documents (as mentioned in cover-1) including EMD, cost of Tender documents in the office of Assistant Inspector General of Police (E), Police Head Quarter, Itanagar, Arunachal Pradesh on **01/08/2023 at 1100 hrs.**
6. In case tender opening day is declared as holiday or bandh call at Itanagar, the tenders shall be received up to next working day till 1100 hrs. and opened on the same day at 1130 hrs.
7. Technical compliance statement should be enclosed along with technical bid clearly specifying deviation, if any for all specifications mentioned in the tender.
8. **The details of Deposit of Earnest Money (EMD):**
 - A. Earnest Money Deposit
 - a) The Earnest Money Deposit shall be retained by the purchaser till submission of Security Deposit.
 - b) No interest will be payable for the EMD and SD by the purchaser.
 - c) The EMDs of unsuccessful bidders will be returned after opening the final bids.
 - B. Forfeiture of Bid Security / EMD:
 - a) If the bidder withdraws the bid after Bid opening during the period of bid validity.
 - b) If the bidder does not accept the correction of errors made to the Bid prices during bid evaluation.
 - c) In case of a successful bidder, if the bidder fails within the specified time limit to sign the Contract Agreement; or
 - d) A successful bidder fails to furnish the 5% of P.O. value as performance Security at the time of signing the Contract Agreement.
9. **Performance Guarantee:**
 - a) Successful tenderers will be required to deposit 5% of the total value of the Contract price as performance security money "or" Performance Guarantee within 15 days from the date of issue of letter of acceptance of tender for the warranty period. The Performance Guarantee has to be drawn in the name of Asstt. Inspector General of Police (E), PHQ, Itanagar payable to SBI, Itanagar, O/o the Director General of Police, Arunachal Pradesh. The same Performance Guarantee will be returned only after completion of the Warranty Period.
 - b) **Conditions:** If the tenderer who fails to supply the material / perform the task assigned to him in the purchase order, within the period prescribed for such delivery specified above, the AIGP (E) or other competent authority, shall be entitled at his discretion to the actions as under:
 - i) Graded liquidated damages for delay in delivery of all or any good or performance of services will be liable for as under:
 - a. For first 15 days @ 1% of the value of the goods.
 - b. For next 15 days @ 2% of the value of the goods.
 - c. For delay of 1 month/over & up to 2 mts @ 4% of the value of the goods.
 - d. Beyond 2 months and up to 4 months @ 5%, of the value of the goods & on expiry of 4 months the contract would automatically get nullified and Bank Guarantee would be invoked.
 - ii) If the tenderer fails to deliver the material as per terms and conditions of P.O. within the stipulated period, the P.O. will be cancelled and will forfeit the EMD/ Security Deposit.
Further, the successful tenders will have to enter into a "DEED OF AGREEMENT" stipulating the Terms and Conditions of the contract with the AIGP (E), PHQ, Itanagar and on behalf of the Governor of Arunachal Pradesh for the performance of the contract on Rs. 100/- Non judicial Paper stamp paper of Arunachal Pradesh, the cost of which has to be borne by the supplier.
10. **Guarantee / Warranty:** The Supplier shall 2 (two) year Warranty for all the equipments mentioned supra supplied under the Contract from the date of installation as specified in the tender schedule.


11. The purchaser shall also have the right to decide whether or not to enter into the maintenance agreement with the Supplier, after the expiry of warranty period.
12. The successful bidder should execute Rate contract Agreement in a non-Judicial stamp paper in the standard proforma valid for a period of 3 years with 7.5% increase in value allowed per year within 10 days from the date of purchase order.
13. Purchaser reserves the right to get the manufacturing capacity of all the companies verified irrespective of their registration status (if applicable).
14. Only reputed manufacturers or their authorized dealers of the stores specified in Tender specification of tender document should respond.
15. Offer from companies whose business activities are limited to procuring items from manufactures, both Indian and foreign and supplying the same to purchaser having no after sales service back up will not be entertained.
16. **Standards:** The goods supplied under this contract shall conform to the standards mentioned in the technical specifications and where no applicable standard have been prescribed, such standards shall be the latest issued by the recognized and accepted quality control institutions.
17. **Patent Rights:** The Bidder shall indemnify the Purchaser against all third-party claims of infringement of patent, trademark or industrial design rights arising from the use of the Goods or any part thereof.
18. **Delegation:** The Purchaser may delegate any office functions / authority to any other competent person or his subordinate official or supervision consultant as the Purchaser think appropriate for effective administration for the contract. However, these delegations will not diminish the overall authority of the Purchaser. The purchaser can review the delegations so made at any time. The delegation of function / authority by the Purchaser shall be intimated to the supplier in writing. The supplier shall designate and authorize a representative to deal with the Department. The name of the supplier's representative shall be notified by the supplier to the purchaser in writing.
19. **Sub-Contract:** The Supplier shall not sub-contract whole or part of the works without the prior consent of the Purchaser. Any such consent shall not relieve the Supplier from any liability or obligation under the contract and he shall be solely responsible for the acts, defaults and neglects of any Sub-Supplier.
20. **Award of Contract:** Prior to the expiry of the period of bid validity, the Purchaser will notify selected Bidder and place the supply order within 7 days thereafter. If a need for extension of the bid validity period arises, it should be extended by mutual agreement. The notification of award / placement of supply order will constitute the formation of the Contract.
21. **Delay in the Suppliers performance:** Delivery of the Goods and performance of services shall be made by the supplier in accordance with the time schedule specified by the purchaser in its Schedule of Requirement. All unexcused delay by the supplier in the performance of its delivery obligations shall render the supplier liable to forfeiture of its performance security bank guarantee, imposition of liquidated damages and or termination of the contract for default.
22. The supplies not distributed and kept uninstalled in the stores for a period of one year and found with any manufacturing defects, color fade etc., are to be replaced free of cost by the supplier and consequential losses borne by Bidder in case of defaults like fading of color etc.
23. The buyer will not pay for transit insurance. The bidder will be responsible until the entire consignment reaches the location as mentioned in the P.O. in good condition.

24. Whenever under this purchase order any sum of money is recoverable / payable by Bidder, the AIGP (E), PHQ, Itanagar shall be entitled to recover such sums by appropriating in part or whole the balance and the total sum / due recoverable, as the case may be, shall be deducted from any sum / due or which any time thereafter money becomes due to the bidder, under this, or any other contract with the Government, such deduction being made from the bidders bills.
25. In case of any breach of contract, Terms of Agreement and Purchase Order and its conditions, the decision of the AIGP (E), PHQ, Itanagar is final and binding on the bidder. In case of any dispute, the matter can be referred to competent Court at Itanagar only and not anywhere else.
26. Rejected goods or materials shall be removed at the expenses of bidder within 15 days, after the notice has been given to the bidder. If not removed the AIGP (E), PHQ, Itanagar may cause the goods or materials to be removed and penalized the bidder with all expenses incurred in such removal.
27. The contract or any part of it shall not be transferred or assigned by the bidder directly or indirectly to any other agencies whom-so-ever without the written consent of the AIGP (E), PHQ, Itanagar.
28. The bill of cost should be submitted in triplicate to this office duly showing Account Numbers IFSC Code of the firm where he holds Bank account and further showing the Tax components separately with all required documents for arranging necessary payment.
29. **ARBITRATION:** "any dispute or difference whatsoever arising between the parties to this Contract out of or relating to the construction, meaning, scope, operation or effect of this Contract or the validity or the breach there of shall be referred to a sole Arbitrator to be appointed by Arunachal Pradesh Police only. If the implementation agency cannot agree on the appointment of the Arbitrator within a period of one month from the notification by one party to the other of existence of such dispute, then the ultimate Arbitrator shall be DGP, AP only. The provisions of the Arbitration and Conciliation Act 1996 will be applicable and the award made there under shall be final and binding upon the parties hereto, subject to legal remedies under the law. Such difference shall be deemed to be a submission to arbitration under the Indian Arbitration and Conciliation Act 1996, or of any modification, Rules or re-enactment thereof. The Arbitration proceedings will be held at Arunachal Pradesh State, India. Any legal dispute will come under Arunachal Pradesh State jurisdiction at Itanagar only."
30. **Government Policy:** The purchaser reserves the option to give a purchase / price preference to offers from the public sector units and / or from other companies in accordance with the policies of the Govt. from time to time.
31. The bidders should keep checking the website for any added / corrigendum to the notice / bidding documents till the date of submission of bids and the bidder should incorporate the same in his bid documents.
32. Conditional bids and the bids not meeting the qualifying criteria on the date of receipt of bids shall be summarily rejected.
33. Bids will be opened as per time & schedule mentioned.
34. Before submission of bids, bidders must ensure that scanned copy of all the necessary documents have been attached with bid.
35. The department will not be responsible for delay in submission due to any reason(s).
36. All the required information for the bid must be filled and submitted.
37. The tender papers containing full details with specifications and terms and conditions can be obtained from Dy. Superintendent of Police (Provisioning), PHQ Itanagar, on payment of tender fee of Rs. 1000/- (Non-refundable through a bank draft in favour of the Asstt. Inspector General of Police (E), PHQ, Itanagar, Arunachal Pradesh payable at S.B.I. Itanagar on any working day from 0930 hrs to 1600 hrs w.e.f. 28/06/2023 to 31/07/2023. The tender documents may also be download from our website. The tenderers

downloading the documents from website are also required to submit a Bank Draft of Rs. 1000/- as tender fees. No other mode of payment will be accepted.

38. Rate should be quoted F.O.R Central Store, PHQ, Itanagar. Rates quoted other than F.O.R Central Store, PHQ, Itanagar shall not be accepted. No packing or forwarding charges will be allowed. The rate of GST (as applicable) may be charged / quoted by the tenderers and the amount be clearly mentioned for all items. The rate should be quoted in Indian currency both in figure and words clearly. Tenders must be eligible and clear in all respect else the tenders shall be liable to be rejected.
39. Tenders should be addressed to the undersigned by designation and not by name. The separate sealed envelope containing the tender should be subscribed as "Tender for supply of Weapon and Ammunition Management System for Up-Gradation of Central Kote at Itanagar, Arunachal Pradesh" and sent by Registered Post/Speed Post/Courier Service or put in the Tender Box kept in the office of the undersigned (Provisioning Branch) on any working day from 0900 to 1700 hrs. **The tenders received after scheduled date & time will not be entertained.**
40. Any breakage or loss of any item will be at the supplier's risk.
41. Delivery of the stores will have to be completed within 120 days from the date of issue of firm order. In case of failure to supply the items in time, violation of any provision of Deed of Agreement, the firm is liable to be blacklisted.
42. If any item is found damaged or otherwise unacceptable at the time of delivery/inspection, the supplier will be required to remove the same from Central Store, PHQ, Itanagar, Arunachal Pradesh at their own cost within 15 days.
43. Payment will be made to the supplier directly on completion of supplies and on receipt of stores on bill-to-bill basis. Documents/vouchers/R.R. S bill etc. routed through bank will not be accepted.
44. The Director General of Police, Arunachal Pradesh, Itanagar reserves the right to reject the lowest or all or any of the tenders without assigning any reason thereof.
45. The Director General of Police of Arunachal Pradesh, Itanagar shall have the right to ask the firms to demonstrate their items before the items are accepted.
46. List of equipments/items with description & specification is enclosed at Annexure- A. The quantities mentioned in the enclosure are all approximation and subject to variation as per actual availability of funds.
47. Tenders will remain valid up to 31-03-2024.
48. All items to be supplied shall be on warranty for a period as mentioned against them in the enclosed list. Where the warranty period has not been mentioned, the minimum warranty period shall be for one year (except consumable items).
49. The vendor/ firm shall submit undertaking to provide after sale services of items / parts to be supplied for minimum period of 5 (five) years from the date of supply of items on an optional AMC ('Annual Maintenance Contract Basis')

Supply of Weapon and Ammunition Management System for Up-Gradation of Central Kote at Itanagar, Arunachal Pradesh


SL No.	Name of Item	Specifications	Quantity Required
1.	High Density Rolling Storage Cabinets (For Weapons and Open Ammunition)	<p>a. BASIC REQUIREMENT: High Density Rolling Storage Cabinets for weapons and open ammunition are required for storing small arms, including rifles, mortars, submachine guns, LMGs, pistols, revolvers, anti-riot guns, and 12 bore guns. The storage system should be track slideable and have a rolling handle on the front panel, and should be flexible enough to store rifles of different calibers, models, and sizes. The purpose of this storage system is not only to save space but also to manage and protect the weapons from unauthorized access, dust, pests, and other environmental elements.</p> <p>2. TECHNICAL DATA: A) The Storage: The storage enclosure should be of slid able on track type, and the sliding movement must be done by rotating the rolling handle on front panel or better. B) The Unit : The Unit should be of following dimensions: Min (Depth:380 (+/- 2) mm, Height:2600 (+/-5) mm, Width:915 (+/-3)mm) or better. C) The Units should be made out of powder coated min 1.5 mm thick CRCA (Cold Rolled & Close Annealed) sheet, duly strengthened by ribs formation with the help of roll forming process, and to be fitted with a specially designed min 2mm thick CRCA mounting panel, permitting weapon holding inserts to be placed at customized positions or better D) The thick mounting panel in each unit should have easy insert locking facility to secure customizable inserts for gripping different rifles of different calibers, models and sizes or better. E) Sturdy Steel Base: The Sturdy Steel Base must be constructed using a minimum of 3mm thick HRCA (Hot Rolled & Close Annealed) "C" section that is bent with the utmost precision on a CNC bending machine. This base will serve as the primary bearing element and support for the storage enclosure. It should also accommodate cast iron wheels with bearings, shafts, and an anti-toppling mechanism or better. F) Track System: Track should be made out of min 2mm thick butterfly section fitted with 30 dia M.S bright bars duly polished and plated or better G) Mechanical device: Mechanical device should be consisted of tri-spoked chrome plated rigid handle with anti-skid device and locking system. The mechanical movement assisted by chain and sprocket drive for smooth rolling or better. H) Weapon mountings: The mountings should be made of special polymer having long life and strong enough to avoid much vibration & noise during sliding movements of the storage. The weapon mounts be tested for min 50,000 cycles or better. I) Painting: This process throughout the whole structure should involve pretreatment with phosphate and then a min 45-to-60-</p>	90 Nos

		<p>micron thick coat of epoxy polyester powder followed by baking at 180-to-200-degree C. The paint should be Anti-Static and Fire Retardant or better.</p> <p>J) Color: Black & White in combination.</p> <p>K) Hardware and fasteners: These should be high tensile galvanized/ blackened fasteners of standard make. All welded joint should be made of spot welding with smooth finish or better.</p> <p>DESIGN PARAMATERS: The designing should consider efficient, compact & collision-free storage, durability, smooth functioning & easy maintenance facility, so that even an un-skilled worker can handle the maintenance. Design should be such that in spite of compactness, handling of one weapon may not affect other weapons or better.</p> <p>A) Knock-down construction or better.</p> <p>B) Must be capable to store a range of Rifles of different calibers & sizes, through adjustment / vertical movement of the flexible clips in the units or better.</p> <p>C) The bidder must provide complete layout (Plan & Elevation) of entire system mentioning dimensional details and 3D drawing/catalogue of the offered system mentioning material details along with the Technical Bid, failing which the offer is liable to be rejected.</p> <p>D) Safety features:</p> <ul style="list-style-type: none"> (i) The design should incorporate adequate factors of safety as per applicable codes of practice and regulations.
