- The interested Internet Service Providers (ISPs) may submit their sealed tender to the office
  of Assistant Inspector General of Police (E), Police Head Quarters, Itanagar, Arunachal
  Pradesh on or before 17/11/2025 at 1100 hrs.
- 2. All the tenders must be accompanied with following documents:
  - a) Earnest Money of Rs.3,92,000/- in the form of TDR / FDR / Demand Draft / NSC / KVP etc. from Nationalized Bank / Post offices duly pledged in favour of Asstt. Inspector General of Police (E), PHQ, Itanagar. The firms registered under MSME are exempted for earnest money "Bidders are required to submit a copy of the MSME registration certificate".
  - b) Attested copy of PAN.
  - c) Attested copy of firm registration.
  - d) Attested copy of firm GST Registration.
  - e) Valid Trading license for Internet Services.
  - f) Certificate/ Letter of authority from OEM/ Service Provider.
  - g) Latest Financially soundness certificate / Bank Solvency Certificate.
  - h) Undertaking letter about non-blacklisting.
  - i) All the tender papers must be serialized/ numbered, and an index/ checklist must be submitted at the beginning of the tender papers indicating the pages of the relevant documents. Tenders without index/ checklist shall be summarily rejected.

- 3. The tenders received after scheduled date & time will not be entertained. The tenders or their representative may remain present at the time of opening of tenders.
- 4. Rates must be clearly written in figures as well as in words, showing GST and other taxes as applicable. There should be no cutting or overwriting.
- 5. Conditional bids and the bids not meeting the qualifying criteria on the date of receipt of bids shall be summarily rejected.
- 6. Bids will be opened as per time & schedule mentioned. In case tender opening day is declared as holiday or bandh call at Itanagar, the tenders shall be received up to next working day till 1100 hrs., and opened on the same day at 1130 hrs.

However, the successful bidder must be prepared to deliver and install the required Internet Connectivity at any location across Arunachal Pradesh. No additional charges for packing, forwarding, or handling will be entertained. Tenders must be legible and clear in all respects else the tenders shall be liable to be rejected.
- 16. Any breakage or loss of items will be at the supplier's risk.
- 17. Supply & Installation of Internet Connectivity will have to be completed within 30 days from the date of issue of supply order. In case of failure to supply the items in time, violation of any provision of Deed of Agreement, the firm is liable to be blacklisted.
