

The sealed tendered/ bids should be superscribed with "Tender for Gym & Fitness Equipment and Addressed to Commandant, 1st AAPBn cum Secretary, APP Sports Control Board, Chimpu, Itanagar, Arunachal Pradesh -791113".

Envelope -1:-Technical Bids - It shall contain copies of eligibility information as under:-

- a) Tender fee should be attached, in case the documents downloaded from website tender fee in form of BD/DD should be attached along with Technical Bid.
- b) Technical bid along with its specification leaflets, brochure & catalogue.
- c) Tender documents duly completed and signed but without indication of the rates quoted.
- d) Earnest Money (EMD) must be attached in form of TDR/FDR/Demand Draft/NSC/KVP etc. of Nationalized Bank/Post office duly pledged in favour of Commandant 1<sup>st</sup> AAPBn, Chimpu, Itanagar. However, NSIC/SSI/UAM-MSME Certificate, applicable to those who are seeking exemption from EMD.
- e) Technical compliance statement should be enclosed along with technical bid clearly specifying deviation, if any for all specifications mentioned in the tender.
- f) Attested copy of PAN Card.
- g) Attested copy of firm GST Registration.
- h) Valid Trading license issued by competent authority for the tendered items.
- i) Letter of OEM Authorized Certificate, if any.
- j) Financially soundness certificate/Bank solvency of firm from the concerned Branch Manager of Bank from where the firm operates.
- k) Attested copy of last three years Income tax return of the firms.
- Experience certificate of firm which must contain name designation, address, Phone No., Fax No., Mail ID (if any) of Issuing Officer. The certificate should be countersigned by concerned OFFICE HEAD/DEPT. HEAD
- m) Any other relevant documents which the firm wishes to submit.

Envelope -2:-Financial Bid - It shall contain documents only "Financial Bid".

a) Rates must be clearly written in figures as well as in words, showing GST separately.



#### **GENERAL INSTRUCTION:**

- 1. The tenders received after schedules date & time will not be entertained. The tenderers or their representative may remain present at the time of opening of tenders.
- 2. There should not be any cutting/over writing.
- 3. The Tenderer/Firms who fail to fulfill the eligibility conditions will be summarily rejected.
- 4. In case tender opening day is declared as holiday or bandh call at Itanagar, the tenders shall be opened on next working day at 1030 hrs.

## 5. The details of Earnest Money Deposit (EMD):

## A. Earnest Money Deposit.

- The earnest Money Deposit shall be retained by the purchaser till submission of Security Deposit.
- b) No interest will be payable for the EMD and SD by the purchaser.
- c) The EMDs of unsuccessful bidder will be returned after opening the financial bids.

## B. Forfeiture of Bid Security/EMD:

- a) If the bidder withdraws the bid after Bid opening during the period of bid validity.
- b) In case of a successful bidder, if the bidder fails within the specified time limit to sign the Contract Agreement; or
- c) If a successful bidder fails to furnish the 5% of contract value as performance Security at the time of signing the Contract Agreement.

#### 6. Performance Guarantee:

- a) Successful tenderer will be required to deposit 5% of the total value of the Contract price as performance security money "or" Performance Guarantee within 15 days from the date of issue of letter of acceptance of tender for the warranty period. The Performance Guarantee has to be drawn in the name of Commandant 1st AAPBn, Chimpu, Itanagar payable at SBI, Itanagar, O/o of the Commandant 1st AAPBn, Chimpu, Itanagar, Arunachal Pradesh.
- b) Conditions: If the tenderer who fails to supply the material/perform the task assigned to him/her in the purchase order, within the period prescribed for such delivery specified above, the Director General of Police, shall be entitled at his discretion to the actions as under:
  - Liquidated damages will charge for delay in delivery of all items or performance of services will be liable for as under:
  - (a) For first 30 days @1% of the value of the goods.
  - (b) For next 60 days @2% of the value of the goods.
  - (c) For delay of 2 month/over &up to 4 months @4% of the value of the goods.
  - (d) Beyond 4 months and upto 6 months @5%, of the value of the goods & on expiry of 6 months the contract would automatically get nullified and Bank Guarantee would be invoked.
  - II. If the tenderer fails to deliver the material as per terms and conditions of P.O. within the stipulated period, the P.O. will be cancelled and will forfeit the Performance Security Deposit. Further, the successful tenderers will have to enter into a "DEED OF AGREEMENT" stipulated in the Terms and Conditions of the contract with the Commandant 1st AAPBn cum Secretary, APP Sports Control Board, Chimpu, Itanagar.



- 7. **Guarantee/Warranty:** The supplier shall provide 05 (Five) year Warranty or as per the prescribed periods by the company/OEM for the equipment's mentioned in the Contract from the date of installation as specified in the tender schedule.
  - a) During warranty period, in case of local service centers complaints should be attended within 05 days and in case of out-station service centers complaints should be attended within 10 days.
  - b) The supplier should provide after sale service for 05 (five) years.
- 8. The buyer will not pay for transit insurance. The bidder will be responsible until the entire consignment reached the location.
- 9. In case of any breach of contract, Terms of Agreement and Purchase Order and its conditions, the decision of the Director General of Police, PHQ, Itanagar is final and binding on the bidder. In case of any dispute, the matter can be referred to competent Court at Itanagar only and not anywhere else.
- 10. The bill of cost should be submitted in triplicate to this office duly showing Account Numbers IFSC Code of the firm where he holds Bank Account and further showing the Tax components separately with all required documents for arranging necessary payment.
- 11. The bidders should keep checking the website for any added/corrigendum to the notice/bidding documents till the date of submission of bids and the bidder should incorporate the same in his bid documents.
- 12. Conditional bids and bids not meeting the qualifying criteria on the date of receipt of bids shall be summarily rejected.
- 13. The department will not be responsible for delay in submission due to any reason(s).
- 14. The tender papers containing full details with specifications and terms and conditions can be obtained from 1<sup>st</sup> AAPBn, BHQ Office, Chimpu, Itanagar, on payment of tender fee of ₹ 1,000/- (Rupees one thousand) only (Non-refundable) through a bank draft in favour of the Commandant 1<sup>st</sup> AAPBn, Chimpu, Itanagar, Arunachal Pradesh payable at S.B.I. - 16. 
