Report on Tawang PS C/No.12/2015 u/s 376 (2)(f) and (i)/354(A)(III) IPC R/W Section 6 and 12 of POCSO Act 2012.

District Police alongwith District Administration has been conducting sensitization programmes for Girl students cross different Schools. One such sensitization programme was organized on POCSO Act 2012, Girls sensitization and Campaign against Drug Abuse, Sexual harassment, and AIDS for girl children along with SSA Zilla Mission Tawang. In the programme, Lady S.I (Name Confidential) acted as a resource person on POCSO Act 2012 and spoke in two schools, Govt. Middle School Kakaling and Govt Secondary School Kipti. At Kipti, girl students around 100 (Hundred) from six different Schools participated. After the sensitization programme, a girl student namely (Name Confidential) age 16 years, Class VIII, of Govt. Secondary School Kipti, daughter of (Name Confidential) came forward and confided in Lady S.I and reported that her uncle (Name Confidential) who is her local guardian in Tawang has been sexually assaulted her since last one and half months and showed pornography against her will. Accordingly a case was registered at PS Tawang FIR No. 12/15 u/s 376 (2)(f) and (i)/354(A)(III) IPC R/W Section 6 and 12 of POCSO Act 2012 on dated 01/08/2015.

The victim was taken in a safe place at Tawang away from her residence as the accused also resided in the same house and her statement was taken in the presence of (Name Confidential) Gender Coordinator, DDSE Office Tawang and member of Women welfare Association Tawang by L/S.I (Name Confidential) . In the course of investigation, the following legal procedures were done

- 1. The Accused (Name Confidential) was arrested on 01/08/2015 at 20.30 hrs and was remanded to police custody for 3 (three) days on production to JMFC Tawang.
- 2. Medical Examination of the victim was carried out by a lady doctor on $\frac{02/08/2015}{02/08/2015}$. Medical examination of the accused was also done on $\frac{02/08/2015}{02/08/2015}$.
- 3. Statement of the victim under 164 CrPC was recorded by JMFC Tawang on 02/08/2015.
- 4. The victim was handed over to the parents on 05/08/2015 after they reached Tawang from U.P
- 5. As per the requirement of the POCSO Act 2012, the accused was produced in the court of Addl. Dist. & Session Judge, Bomdila, West Kameng District, on 07/08/2015.
- 6. Exhibits of the case has been forwarded to FSL for Expert opinion and DNA Analysis.

The case in pending for further investigation.

This case of sexual assault came into light due to the initiative of District Police and especially due to the effort of Lady S.I (Name Confidential) without which it would have gone unnoticed.
